Annual Subscriptions - Pay by Instalment Plan Application for 2024/25

Please note – the Instalment Plan is only available to members in a playing category.

For Members' convenience, Green Acres Golf Club offers a monthly instalment option for the payment of Annual Subscriptions via Direct Debit.

Members who choose to pay their subscriptions by instalments remain liable for the full Subscription amount.

Please note the instalment option applies to the Annual Subscription (GST inclusive) only, and all other ancillary items such as Golf Australia affiliation, Personal Insurance Plan, Locker Fees, Competition fees and Club Storage as detailed on your renewal invoice are due and payable in full and will be deducted by the Club <u>in addition</u> to your first subscription instalment.

If a Member's Direct Debit payment is denied at any time, the Member will be unfinancial in the membership system and then be liable for any associated fees and charges. Members wishing to amend a Direct Debit arrangement must give the Club notice in writing, 14 days prior to the date of the next instalment, as detailed in the Service Agreement.

Security will be held in the form of a current credit card to which the Club will charge an instalment in the event of a rejection of the primary form of payment.

*Please note that monthly House Accounts do not form part of this arrangement and will be invoiced separately and require payment by existing methods.

SUBSCRIPTION INSTALMENT OPTION - PAID OVER NINE (9) INSTALMENTS.

One-ninth of your annual subscription (including an account keeping fee plus all ancillary charges) will be debited from your nominated bank account on the first Thursday 4th April 2024. Eight additional payments equal to one-ninth of your subscription inclusive of an account keeping fee will be debited from your nominated account via Direct Debit on the first Tuesday of each month, up to and including the first Tuesday in December 2024.

In accordance with our commitment to you, a full schedule of the total fees payable and the dates which each amount will be debited from your nominated bank account will be sent to you upon acceptance by Green Acres Golf Club of this application.

Pay by Instalment Service Agreement – 2024/25

General

 In the interpretation of this agreement words importing any gender include any other gender, words importing the singular number include the plural number and vice versa; words importing persons include corporations and any covenant or agreement in the part of two or more persons shall be deemed to bind them jointly and severally.

Approval

The Members application shall not constitute a binding agreement between the parties until the application is accepted by Green Acres and a valid Direct Debit agreement received.

Payment

- 1. The Member agrees to the monthly instalments referred to by Direct Debit. Each monthly instalment is payable in accordance with note 5.
- 2. Green Acres has by this agreement been approved to recover a rejected instalment payment by a charge to the Member credit card. The Member shall be advised when this occurs.
- 3. Green Acres will levy an annual account keeping fee for this service.
- 4. GST is payable on each instalment, and inclusive of the instalment amount advised.
- 5. Instalments will be processed on the first Tuesday of every month commencing in April and terminating in December (inclusive). If the nominated day is a public holiday, then the instalment will be debited the next available business day.

Acknowledgement

- 1. Until repayment in full of the total amount repayable under the terms of the instalment plan by the Member, the Member shall remain a debtor of Green Acres for all unpaid money.
- 2. The Member has authorised Green Acres to immediately charge their credit card only if a direct debit instalment fails, without reference to the Member. The Member will be advised of the action taken within 7 days.

Defaults of payment

- If any Monthly Instalment payment is defaulted, and the subsequent alternative credit card payment also fails, the member authorises Green Acres to take whatever necessary actions that may be required to discontinue the Instalment Plan. The Member will be liable to pay immediately, or on demand any amounts outstanding (under the terms of this Instalment Plan, including fees and charges) to Green Acres, its agents or assignees.
- 2. The Member shall pay to Green Acres on demand all unpaid instalments plus expenses (including enforcement expenses, if any), subject to compliance by Green Acres with any applicable laws.
- 3. The Member shall have their playing rights immediately suspended on any default on this agreement until such time that all amounts due and payable have been received by the club.
- 4. The Member shall pay a late payment penalty of \$25 if any instalment is not made on time.
- 5. The Member shall not be entitled to participate in the instalment program in the following fiscal year if more than one default occurs.

Our commitment to you,

Drawing arrangements:

- We will advise you, in writing, the details of Green Acres Golf Club Instalment Plan drawing arrangements including amount, frequency and commencement date;
- We will keep all information pertaining to your nominated account at the Financial Institution private and strictly confidential.

Your rights:

- You may terminate Green Acres Golf Club Plan drawing arrangements at any time by giving written notice directly to us, or through your nominated Financial Institution. Notice given to us should be received by us at least 14 business days prior to the due date. (If a termination request is lodged, the full amount outstanding becomes immediately due and payable.)
- You may stop payment of a drawing under Green Acres Golf Club Instalment Plan by giving written notice directly to us, or through your nominated Financial Institution. Notice given to us should be received by us at least 14 business days prior to the due date. (If a stop payment request is lodged, the full amount outstanding becomes immediately due and payable.)
- Where you consider that a drawing has been initiated incorrectly [outside Green Acres Golf Club Instalment Plan arrangements] you may take the matter up directly with us or lodge a Direct Debit Claim through your nominated Financial Institution.

Your responsibilities:

I agree that by signing this form

- I understand that I am signing up for the full twelve months of Membership subscription at Green Acres Golf Club in the category I have selected;
- I understand that I am liable for the full payment of this Membership including any fees and charges stated on my invoice, and as prescribed by the Board;
- I understand that should I have more than one forfeited payment that the full amount of the remaining Membership subscription money for the year shall be due at that time and I will not be permitted to participate in the Instalment plan the following year;
- I understand that should I default on payment of my obligated instalments and the Club is unable to settle the issue with me, that the Club shall have the option to approach a debt collection agency to recover the money, and that my credit rating may be affected by this action;
- It is my responsibility to ensure that sufficient funds are available in the nominated account to meet a drawing on its due date;
- It is my responsibility to ensure that the authorisation given to draw on the nominated account is identical to the account signing instruction held by the Financial Institution where the account is based;
- It is my responsibility to advise the Club if the account nominated by myself to receive Green Acres Golf Club Instalment Plan drawings is transferred or closed;
- I understand that by participating in this form of Membership payment, I shall have all the same rights and privileges as any Member, in the category I have elected to join or renewed in.
